EMERGENCY FINANCIAL ASSISTANCE

IMPACT Community Action Emergency Assistance

- Must be a Franklin County resident with a household income up to either 80% AMI or 200% FPL.
- Required documentation: Photo ID, SSN for all household members, 90 days' proof of income (all household members 18 years or older), utility bills, past due rent notice, signed lease, and may require a birth certificate.
- Utility Assistance: Call 614-964-2906 or apply online at <https://apply.impacthopefund.org>
- HEAP - The Home Energy Assistance Program (HEAP) helps households prevent energy service disruptions, restore disconnected services, and/or secure seasonal heating and cooling energy needs. Customers can call to schedule an appointment at 614-246-0019 or walk-in at 8AM M-F or 1PM M-W & F, on a first come first served basis.

- Mortgage assistance: Call 614-964-2906, we are unable to assist clients with mortgages through website.

Franklin County PRC Program and PRC Plus Program for Families Struggling to Meet Rent or Facing Eviction

- Franklin County is providing relief for eligible families struggling to meet rent or facing eviction through the [Prevention, Retention and Contingency \(PRC\) and the new PRC Plus Rental Assistance Programs](#). These programs offer one-time rental assistance payments for Franklin County families with minor children or a pregnant woman in her third trimester: If COVID-19 related up to 300% of the federal poverty level (FPL); If not COVID-19 related then up to 165% FPL.
- If a family qualifies, Franklin County may be able to cover the past due rent up to \$1,500. If the need is COVID related families may also be eligible for one additional month of rent up to \$1,500.
- Rental assistance payment(s) are made directly to the landlord.
- While standard PRC is available year-round, the PRC Plus Rental Assistance Program is only available June 1, 2020 through December 15, 2021 or until funds have been exhausted, whichever comes first. FCDJFS cannot process or pay any PRC Plus application that is incomplete or missing required verification's as of Dec. 15, 2021.

Franklin County Emergency Rental Assistance Program

- This newly added program has the flexibility to pay up to 100% of delinquent rent costs for families impacted by COVID. If the past due rent does not exceed the program cap on the number of months of assistance allowed families may also be eligible for prospective months. This program also assists with utility payments.
- Families must have a minor child or a pregnant woman in her 3rd trimester, in the household; live in Franklin County; must have a social security and meet the citizenship requirements. The household income threshold for this program is 80% Area Median Income (AMI)
- Applicants one application for these the three programs listed here. Staff will assess eligibility for all programs. The Application link is the same as listed above. The program is available June 1, 2021 through December 31, 2021 or until funds have been exhausted.

Must be 138% of poverty level and have unforeseeable hardship. • CARES assists persons 60 and older who reside in Franklin County. Must meet income within 200% of poverty level and have a COVID-19 related hardship. Funds are limited. • Contact COAAA at 614-645-7250
